


U.S. Trade During Globalization Era



Globalization's Institutions and Growth

- World Trade Organization created in 1994.
 - Grows to 166 member countries, with 99% of global GDP
 - China joins WTO in 2001. At that point China's economy was roughly the size of Italy. Today it is the second largest at nearly \$20 trillion.
- North American Free Trade Agreement (1992)
 - Trade between the US, Canada, and Mexico grows from \$290 billion in 1993 to over \$1.1 trillion in 2016
- European Union (EU) launches the Euro in 1999.
 - Unlike NAFTA, EU eliminates restrictions on movement of people. Estimates free movement of people increases GDP by 1% per country

Anti-Globalization sentiment always present just untapped by either party until Trump



Modelling Trade with Tariffs and Uncertainty

Basic model with and without uncertainty

$$T_{ij,t} = E_t[t_{ij,t+1}] + (1 + t_{ij,t}) ER_{ij,t}$$

$$T_{ij,t} = UE_t[t_{ij,t+1}] + E_t[t_{ij,t+1}] + (1 + t_{ij,t})ER_{ij,t}$$

 $T_{ij,t}$ is the present tariff rate, $E_t[t_{ij,t+1}]$ is the expectation of the future tariff rate, $ER_{ij,t}$ is the bilateral exchange rate, $UE_t[t_{ij,t+1}]$ is the uncertainty over future tariff rates.

If the future is known uncertainty is zero, and equation 2 equals equation 1

Modelling Tourism

Equation:

$$T_{ij,t}^{\text{tourism}} = (1 + r_{ij,t}) ER_{ij,t} + \gamma P_{ij,t}$$

 $R_{ij,t}$ is the level of travel restrictions (e.g., visa fees), ER remains the exchange rate, and $\gamma P_{ij,t}$ measures reputational perception.

Examining Reputational Perception

Equation

$$P_{ij,t+1} = P_{ij,t} - \alpha^- N_{ij,t}^- + \alpha^+ N_{ij,t}^+$$


 $N_{ij,t}^-$ and $N_{ij,t}^+$ represent negative and positive perception shocks (e.g., conflicts, threats, major events). α^- and α^+ are their respective saliencies. This allows model to show large impact for a highly salient minor event (e.g., publicity around a single crime, even if overall crime does not change)

Thesis: Trump Impact on Tourism Will Outlast Tariffs


- The stickiness of perceptions of America as a destination for travel, tourism, education, is greater than the stickiness of concerns about future tariff rates and associated uncertainty of future tariff prices.
 - P > E from equations above
- Negative shocks to perception of America are not necessarily correlated with tariffs.
 - Trump's decisions on who to insult are not the same as who to tariff.
- Tariffs are easier to remove than negative perceptions

Canada and Las Vegas

- Canada is #1 source of international tourists for Las Vegas: 1.5 million (1 out of every 27 Canadians) out of 5 million.
- Trump insults Canada calling it 51st state, discusses annexation.
- "This is not a joke.. We're insulted. We're mad. We're Angry"
 Canadian Foreign Minister
- 8 out of 10 Canadians disapprove of Trump (between Xi and Putin)
- 25% decline in Canadian travel to Las Vegas April July 2025
- Potential loss of 450,000+ travelers = \$535 million lost in Las Vegas annual economy

Brazil and Florida (Miami)

- 1.9 million Brazilians visited US in 2024. 1.1 million go to Florida, second largest international visitors to the Sunshine state.
- Trump Administration increases visa fees for Brazilians by \$250 (to \$442).
- Closes consulate in Belo Horizonte, Brazil's third largest metro.
- Trump attacks current Brazilian government but supports former
- International air travel from Brazil down 6% to Miami in 2025 (YTD)


Japan and Hawaii

- 700,000 Japanese visitors to Hawaii in 2024 out of 2 million total international.
- Japanese travel to US remains below pre-Covid (1.5 million to Hawaii in 2019)
 - Exchange rate
 - Lingering effects of pandemic
- Japanese not yet attacked by Trump and seem more open than many others.
 - Potential for Japan to increase travel to US while others decrease:
 - Japanese travel to Hawaii increased 7.5% April to July 2025



Geography of Trade in Goods: Example: Soybean **Production** in the United States


